- The Japanese internet access market recorded revenues of \$17,097.8 million in 2024, representing a negative compound annual growth rate (CAGR) of 4.3% between 2019 and 2024.
- Market consumption volume increased with a CAGR of 0.8% between 2019 and 2024, reaching a total of 121,609.9 thousand internet users in 2024.
- Japan accounted for a share of 5.2% of the Asia-Pacific internet access market in 2024.
