- The Russian internet access market recorded revenues of \$2,620.7 million in 2024, representing a negative compound annual growth rate (CAGR) of 0.1% between 2019 and 2024.
- Market consumption volume increased with a CAGR of 2.4% between 2019 and 2024, reaching a total of 126,965.5 thousand internet users in 2024.
- Russia accounted for a share of 3.5% of the European internet access market in 2024.
