Market volume represents the number of internet users in a specific country in a year.
- The Singaporean internet access market recorded revenues of \$453.4 million in 2024, representing a compound annual growth rate (CAGR) of 1.5% between 2019 and 2024.
- Market consumption volume increased with a CAGR of 1.6% between 2019 and 2024, reaching a total of 5,017.4 thousand internet users in 2024.
- Singapore accounted for a share of 0.1% of the Asia-Pacific internet access market in 2024.
