- The South African internet access market recorded revenues of \$1,307.2 million in 2024, representing a negative compound annual growth rate (CAGR) of 9.9% between 2019 and 2024.
- Market consumption volume increased with a CAGR of 5.0% between 2019 and 2024, reaching a total of 45,848.5 thousand internet users in 2024.
- South Africa accounted for a share of 14.6% of the Middle East & African internet access market in 2024.
