- The Swiss power generation industry recorded revenues of \$3.5 billion in 2024, representing a compound annual growth rate (CAGR) of 0.1% between 2019 and 2024.
- Industry production volumes declined with a negative CAGR of 0.1% between 2019 and 2024, reaching a total of 67,707.1 GWh (gigawatt-hours) in 2024.
- Switzerland accounted for a share of 1.2% of the European power generation industry in 2024.
