Market volume represents the net volume of electricity produced through renewable means. Market value is calculated by multiplying the amount of electricity produced by the wholesale price.
- The Canadian renewable energy market recorded revenues of \$28,874.3 million in 2024, representing a negative compound annual growth rate (CAGR) of 0.02% between 2019 and 2024.
- Market production volume increased with a CAGR of 0.1% between 2019 and 2024, reaching a total of 414,618.2 GWh in 2024.
- Canada's climate and pollution goals have significantly supported the growth of its renewable energy market by driving a structural shift away from fossil fuel dependence. According to the US Energy Information Administration (EIA), in 2024, the proportion of fossil fuels in total power generation in Canada reached 17.3%, down from 18.0% in 2019.
