- Renewable energy market includes net generation of electricity through renewable sources. Market is segmented into hydroelectricity, wind, solar PV, biopower, and geothermal. Market volume represents the net volume of electricity produced through renewable means. Market value is calculated by multiplying the amount of electricity produced by the wholesale price.
- The Israeli renewable energy market recorded revenues of \$225.1 million in 2024, representing a compound annual growth rate (CAGR) of 23.1% between 2019 and 2024.
- Market production volume increased with a CAGR of 24.6% between 2019 and 2024, reaching a total of 10,310.7 GWh in 2024.
- Israel's climate and pollution goals have significantly supported the growth of its renewable energy market by driving a structural shift away from fossil fuel dependence. According to the US Energy Information Administration (EIA), in 2024, the proportion of fossil fuels in total power generation in Israel reached 90.6%, down from 91.2% in 2023.
