- The Portuguese renewable energy market recorded revenues of \$2,510.6 million in 2024, representing a compound annual growth rate (CAGR) of 4.8% between 2019 and 2024.
- Market production volume increased with a CAGR of 5.9% between 2019 and 2024, reaching a total of 35,813.4 GWh in 2024.
- Portugal's climate and pollution goals have significantly supported the growth of its renewable energy market by driving a structural shift away from fossil fuel dependence. According to the US Energy Information Administration (EIA), in 2024, the proportion of fossil fuels in total power generation in Portugal reached 40.5%, down from 47.1% in 2019.
