Market volume represents the net volume of electricity produced through renewable means. Market value is calculated by multiplying the amount of electricity produced by the wholesale price.
- The Romanian renewable energy market recorded revenues of \$1,637.0 million in 2024, representing a compound annual growth rate (CAGR) of 4.8% between 2019 and 2024.
- Market production volume increased with a CAGR of 5.0% between 2019 and 2024, reaching a total of 30,523.7 GWh in 2024.
- Romania's climate and pollution goals have significantly supported the growth of its renewable energy market by driving a structural shift away from fossil fuel dependence. According to the US Energy Information Administration (EIA), in 2024, the proportion of fossil fuels in total power generation in Romania reached 38.6%, down from 40.0% in 2019.
