- The South Korean renewable energy market recorded revenues of \$8,159.4 million in 2024, representing a compound annual growth rate (CAGR) of 6.1% between 2019 and 2024.
- Market production volume increased with a CAGR of 4.1% between 2019 and 2024, reaching a total of 57,897.8 GWh in 2024.
- In 2024, the South Korean renewable energy production recorded an annual growth of 11.4% due to the substantial increase in installed renewable energy capacity. According to the US EIA, in 2024, the South Korean renewable electricity installed capacity reached 33.2 million kilowatts (kW), up 10.2% annually.
