- The Czech renewable energy market recorded revenues of \$908.5 million in 2024, representing a compound annual growth rate (CAGR) of 4.5% between 2019 and 2024.
- Market production volume increased with a CAGR of 5.5% between 2019 and 2024, reaching a total of 12,635.5 GWh in 2024.
- In 2024, the Czech renewable energy production recorded an annual growth of 10.3% due to the substantial increase in installed renewable energy capacity. According to the US EIA, in 2024, the Czech renewable electricity installed capacity reached 5.1 million kilowatts (kW), up 1.4% annually.
