- Renewable energy market includes net generation of electricity through renewable sources. Market is segmented into hydroelectricity, wind, solar PV, biopower, and geothermal. Market volume represents the net volume of electricity produced through renewable means. Market value is calculated by multiplying the amount of electricity produced by the wholesale price.
- The Vietnamese renewable energy market recorded revenues of \$4,115.6 million in 2024, representing a compound annual growth rate (CAGR) of 8.9% between 2019 and 2024.
- Market production volume increased with a CAGR of 10.9% between 2019 and 2024, reaching a total of 122,245.6 GWh in 2024.
- In 2024, Vietnamese renewable energy production recorded an annual growth of 2.6% due to the substantial increase in installed renewable energy capacity. According to the US EIA, in 2024, the Vietnamese renewable electricity installed capacity reached 50.5 million kilowatts (kW), up 5.4% annually.
