The global engineered wood market reached a value of approximately USD 331.24 Billion in 2024. The market is further expected to grow at a CAGR of 6.10% between 2025 and 2034, reaching a value of USD 598.82 Billion by 2034.

Engineered wood, also termed as man-made wood, is a type of wood that is made by binding pieces of scrap wood, sawdust, real wood, or shredded wood fibres using adhesives. It is called engineered wood because it is bonded together to form a stronger and stiffer end product.

- The demand for engineered wood is rising from the construction industry due to its sustainability and as it offers similar strength and density as an old growth timber.
- Growing utilisation of engineered wood instead of greenhouse gas emission intensive materials such as steel, aluminium, and concrete is reducing the emission of greenhouse gases, and aiding the growth of the engineered wood market.
- The rising trend of remodelling and renovating older homes and growing demand for wooden floorings are major factors increasing the utilisation of engineered woods in various countries across the globe.
