In this regard, start-ups in the region are increasingly investing in the development of solid and liquid egg substitutes. For instance, in December 2021, Perfeggt, a German start-up, announced the launch of its animal-free egg substitute, which is expected to be available in Switzerland, Germany, Austria, and other regions of Europe in 2023. Such developments are expected to augment the market growth in the forecast years.

Solid Egg Substitutes: Market Segmentation

Solid egg substitutes refer to products or ingredients that can alternate for solid eggs. These alternative products provide similar functional properties to eggs and can replace them in either cooking or for direct consumption. They can be soy-based or can also be made out of starch, such as potato or tapioca starch.
