The global UHT processing market reached value of more than USD 4.66 Billion in 2024 . The industry is further expected to grow at a CAGR of 12.20% in the forecast period of 2025-2034 to reach a value of over USD 14.73 Billion by 2034 .

Europe and North America to Account for a Significant Share in the Global Market for UHT Processing

As a result of increased milk consumption and strict guidelines and regulations for manufacturers, Europe is one of the leading regions contributing to the market growth of UHT processing. Fruit juices, cream, soy milk, yoghurt, wine, soups, honey, stews, and a variety of other items can benefit from UHT processing. The steriliser and aseptic unit are combined in UHT processing. Maximum microbial annihilation is achieved with minimal chemical changes in the food and beverage product during UHT processing.
