- Within the construction materials industry, China is the leading country among the top 5 emerging nations, with market revenues of \$6,57,575.1 million in 2024. This was followed by India and Mexico with a value of \$92,507.1 and \$19,424.2 million, respectively.
- China is expected to lead the construction materials industry in the top five emerging nations, with a value of \$8,30,728.6 million in 2029, followed by India and Mexico with expected values of \$1,21,620.4 and \$22,345.5 million, respectively.
