The top 5 emerging countries are expected to reach a value of \$14,78,019.8 million in 2029, with a CAGR of 3% over the 2024-29 period.
- Within the foodservice industry, China is the leading country among the top 5 emerging nations, with market revenues of \$8,78,627.3 million in 2024. This was followed by India and Brazil with a value of \$1,59,806.7 and \$1,09,489.1 million, respectively.
- China is expected to lead the foodservice industry in the top five emerging nations, with a value of \$9,60,654.8 million in 2029, followed by India and Brazil with expected values of \$2,27,348.9 and \$1,41,209.0 million, respectively.
