The waste management industry within the NAFTA countries had a total market value of \$9,43,747.0 million in 2024. The US was the fastest growing country, with a CAGR of 3.7% over the 2020-24 period.
- Within the waste management industry, the US is the leading country among the NAFTA bloc, with market revenues of \$7,80,113.8 million in 2024. This was followed by Canada and Mexico, with a value of \$1,59,147.1 and \$4,486.2 million, respectively.
- The US is expected to lead the waste management industry in the NAFTA bloc, with a value of \$10,31,880.6 million in 2029, followed by Canada and Mexico with expected values of \$2,01,424.2 and \$5,792.6 million, respectively.
