- Within the containers & packaging industry, China is the leading country among the BRIC nations with market revenues of \$73.3 billion in 2024. This was followed by Russia, Brazil and India with a value of \$32.1, \$24.6, and \$20.2 billion, respectively.
- China is expected to lead the containers & packaging industry in the BRIC nations with a value of \$86.0 billion in 2029, followed by Russia, Brazil, India with expected values of \$37.9, \$27.5 and \$24.3 billion, respectively.
