- The Canadian foodservice industry recorded revenues of \$87,891.3 million in 2024, representing a compound annual growth rate (CAGR) of 2.1% between 2019 and 2024.
- Industry consumption volume increased with a CAGR of 1.4% between 2019 and 2024, reaching a total of 8,267.3 million transactions in 2024.
- Canada accounted for 5.2% of the North American foodservice industry in 2024.
