- Foodservice is defined as the total value of all food and drink, including on-trade drinks consumed without food, which is intended for immediate consumption either on the premises, in designated eating areas shared with other foodservice operators, or as takeaway transactions involving freshly prepared food for immediate consumption.
- The German foodservice industry recorded revenues of \$91,234.3 million in 2024, representing a negative compound annual growth rate (CAGR) of 2.6% between 2019 and 2024.
- Industry consumption volumes declined with a negative CAGR of 4.3% between 2019 and 2024, reaching a total of 8,398 million transactions in 2024.
- Germany accounted for 10.7% of the European foodservice industry in 2024.
