- The Singaporean foodservice industry recorded revenues of \$10,682.3 million in 2024, representing a compound annual growth rate (CAGR) of 1.9% between 2019 and 2024.
- Industry consumption volume increased with a CAGR of 0.1% between 2019 and 2024, reaching a total of 1,206.2 million transactions in 2024.
- Singapore accounted for 0.6% of the Asia-Pacific foodservice industry in 2024.
