- Market production volume increased with a CAGR of 1.8% between 2019 and 2024, reaching a total of 306.0 million tonnes in 2024.
- According to GlobalData, Asia-Pacific held 43.1% of the global meat & livestock market in 2024, with Europe following at 22.3%. The global meat & livestock market experienced moderate growth during the historic period 2019-24, supported by rising consumer demand for premium, organic, and convenience-oriented meat products, along with productivity improvements in key regions.
