- The German meat & livestock market recorded revenues of \$20.7 billion in 2024, representing a compound annual growth rate (CAGR) of 3.1% between 2019 and 2024.
- Market production volumes declined with a negative CAGR of 2.8% between 2019 and 2024, reaching a total of 6.8 million tonnes in 2024.
- According to GlobalData, Germany held 12.0% of the European meat & livestock market in 2024. The market recorded moderate growth during 2019-24, supported by rising demand for premium and convenience-oriented meat products, along with a recovery in production volumes.
