- Market consumption volume increased with a CAGR of 1.4% between 2019 and 2024, reaching a total of 55.7 million subscriptions in 2024.
- In 2024, the revenue of Taiwan's telecommunication services market grew by 5.8% annually, due to the increase in the proportion of internet users. According to the World Bank, in 2024, the proportion of internet users in Taiwan's total population reached 95.8%, up from 94.9% in the previous year.
