#### Summary

- Wireless telecommunications services market includes cellular (mobile) phones, pagers, and any other wireless or cellular telecommunication service. Market values represent revenues based on payments to operators of all these services for subscriptions and usage. Market volumes refer to the total subscriptions for each of these services. Market shares represent subscription volumes.
- The Egyptian wireless telecommunication services market recorded revenues of \$3 billion in 2024, representing a compound annual growth rate (CAGR) of 0.2% between 2019 and 2024.
- Market consumption volume increased with a CAGR of 5.3% between 2019 and 2024, reaching a total of 129 million subscriptions in 2024.
- The market growth in Egypt's wireless telecommunications declined, due to the impact of persistent inflation, which significantly constrained consumer spending. According to the Central Agency for Public Mobilization and Statistics (CAPMAS), urban inflation reached 26.4% in September 2024, reflecting a sharp rise in the cost of living.
