- The Nigerian wireless telecommunication services market recorded revenues of \$2.5 billion in 2024, representing a negative compound annual growth rate (CAGR) of 17.7% between 2019 and 2024.
- Market consumption volumes declined with a negative CAGR of 4.4% between 2019 and 2024, reaching a total of 144 million subscriptions in 2024.
- In 2024, Nigeria's wireless telecommunications market experienced a decline, primarily driven by persistent inflation and broader economic challenges that constrained consumer spending. According to the National Bureau of Statistics, inflation rose from 33.9% in October to 34.6% in November 2024, significantly increasing the cost of living and reducing household disposable income.
