- Market consumption volume increased with a CAGR of 1.8% between 2019 and 2024, reaching a total of 42 million subscriptions in 2024.
- The growth of the wireless telecommunications market in Peru has been significantly influenced by the steady rise in mobile internet subscribers. According to the Organisation for Economic Co-operation and Development (OECD), the number of mobile internet subscribers in Peru increased by 4.3% in 2024, reflecting a broader trend toward mobile-first connectivity.
