- Within the steel industry, China is the leading country among the BRIC nations with market revenues of \$7,56,772.8 million in 2024. This was followed by India, Russia and Brazil with a value of \$1,11,504.0, \$55,591.8, and \$27,004.6 million, respectively.
- China is expected to lead the steel industry in the BRIC nations with a value of \$8,72,386.5 million in 2029, followed by India, Russia, Brazil with expected values of \$1,36,032.1, \$62,361.9 and \$32,587.5 million, respectively.
