The water utilities industry within the NAFTA countries had a total market value of \$633.1 billion in 2024. The Mexico was the fastest growing country, with a CAGR of 11.7% over the 2020-24 period.
- Within the water utilities industry, the US is the leading country among the NAFTA bloc, with market revenues of \$563.7 billion in 2024. This was followed by Mexico and Canada, with a value of \$56.7 and \$12.7 billion, respectively.
- The US is expected to lead the water utilities industry in the NAFTA bloc, with a value of \$827.6 billion in 2029, followed by Mexico and Canada with expected values of \$77.8 and \$18.2 billion, respectively.
