Calcium Carbide: Market Segmentation

Calcium carbide refers to a chemical compound with the CaC_2 chemical formula. Its main industrial use is in the manufacture of acetylene and calcium cyanamide. The pure content is colourless, but the parts of technical grade calcium carbide are grey or brown and consist of approximately 80-85 percent of CaC_2 . In the presence of trace moisture, the technical grade of calcium carbide emits an unpleasant smell reminiscent of garlic.
