The global cyclohexylamine market is being aided by the rising boiler water treatment market, which attained USD 3.84 Billion in 2024. The global boiler water treatment market is expected to grow at a CAGR of 5.30% in the forecast period of 2025-2034 to reach a value of approximately USD 6.44 Billion by 2034.

Increasing Demand for Corrosion Inhibitors to Bolster the Growth of the Cyclohexylamine Industry

On the basis of application, the corrosion inhibitor segment is likely to propel the market growth owing to the rising demand for environment-friendly corrosion inhibitors, which ensure sustainable development. Meanwhile, as rubber processing generates a large amount of wastewater, the application of cyclohexylamine in both rubber processing and wastewater treatment is further expected to accelerate the market in the forecast period. The artificial sweetener segment also accounts for a significant share in the market, owing to the rising demand from the food and beverage industry.

The Asia Pacific accounts for a significant share in the market. This can be attributed to the significantly growing rubber chemicals and corrosion inhibitor industries in the region. China is one of the leading the regional markets for cyclohexylamine in the Asia Pacific in terms of production and consumption. Meanwhile, Europe too accounts for a healthy share in the market, owing to the rising wastewater concerns and regulations in the region.

Cyclohexylamine: Market Segmentation

Cyclohexylamine is a colourless liquid that is flammable and has a pungent odour. It is used in organic synthesis and to prevent corrosion in boilers. With a boiling point of 134.5 degrees Celsius, the product is soluble in water and can be mixed and dissolved with ethanol, ether, acetone, ethyl acetate, chloroform, heptane, benzene, and other common organic solvents.
