Leading European nations like the UK, Spain, France, and Germany, among others, are constantly developing and investing in energies that are environment friendly, biodegrade, and sustainable. Traditional fuel combustion is considered to have a negative impact on the environment as the combustion releases toxins, which causes problems like air pollution and health problems like bronchitis and asthma.

As a result, policies such as the Renewable Energy Directive (RED II), which aims at increasing the adoption of biofuel in different sectors, including transport and aviation, are positively influencing the growth of the regional market. Furthermore, as a part of the European Green Deal, the European Commission has been promoting the development of sustainable aviation fuels to meet Paris Agreement climate change targets in handling carbon emissions for the aviation industry. These factors are hence augmenting the growth of the market.

Biodiesel: Market Segmentation

Biodiesel, a clean-burning fuel, is produced via transesterification of recycled cooking oils and animal fats. As compared to fossil fuel, biodiesels are non-toxic, carbon-neutral, and are thus environment friendly.

#### Favourable Government Policies to Boost the Market Growth of Biodiesel in Europe

The European biodiesel market has been significantly led by the implementation of policies like the European Green Deal in December 2019, which has a target of increasing greenhouse gas savings (GHG) from biofuels from 40% to 55% making Europe climate neutral by 2050. However, the advent of the COVID-19 pandemic negatively impacted the market for biodiesel in Europe due to the restrictions imposed on travel and international trade. In addition to this, deforestation has been a crucial factor impeding the production of palm oil for biofuel, leading to limitations in supply and international exports of the product. Furthermore, Argentina is considered as one of the major suppliers of soybean in Europe, but due to changes in the production and consumption patterns regarding soybean, the market growth for soy-derived biodiesel witnessed hindrance.

However, the French legislature's measures to cap soy-derived biodiesel to reduce import dependency on protein steer away from GMO and unsustainable crops and augment the use of rapeseed oil and sunflower oil as primary feedstocks for biofuel are projected to positively influence the market growth.
