The global plasticisers market reached a value of almost USD 21.47 Billion in 2024 . The market is further expected to grow at a CAGR of 3.50% in the forecast period of 2025-2034, to reach USD 30.29 Billion by 2034 .

North America to Witness a Significant Growth in the Plasticisers Industry

Region-wise, the North America region is a significant market for the plasticisers. This can be attributed to the growing application of the product in thriving industries like chemicals, healthcare, and packaging. Europe is an established market for plasticisers as the region is witnessing stable growth in both the manufacturing and healthcare industries . The Asia Pacific market is also a flourishing market for plasticisers as the regional market is governed by factors such as changing lifestyles, inflating disposable incomes, and rapid urbanisation. Regions such as Western Europe, North America, and the Asia Pacific, excluding Japan, are estimated to hold the largest share in the plasticisers industry.
