Market volume represents the consumption of biofuel in a country in a specific year. Market value is calculated by multiplying market volume by the wholesale price of biofuel.
- The Asia-Pacific biofuels market recorded revenues of \$47,614.7 million in 2024, representing a compound annual growth rate (CAGR) of 8.7% between 2019 and 2024.
- Market consumption volume increased with a CAGR of 3.2% between 2019 and 2024, reaching a total of 230,278.9 thousand barrels in 2024.
- China accounted for 36.9% of the Asia-Pacific biofuels market in 2024, followed by India with a 10.9% share and Japan with a 5.1% share.
