- The French electricity retailing market recorded revenues of \$82.1 billion in 2024, representing a negative compound annual growth rate (CAGR) of 1.0% between 2019 and 2024.
- Market consumption volumes declined with a negative CAGR of 0.9% between 2019 and 2024, reaching a total of 430.9 TWh in 2024.
- In 2024, the revenue of the French electricity retailing market recorded an annual contraction of 0.3% driven by a decline in electricity prices due to an oversupplied market amid subdued demand.
