- Market consumption volume increased with a CAGR of 2.3% between 2019 and 2024, reaching a total of 300.4 TWh in 2024.
- In 2024, the revenue of the Turkish electricity retailing market recorded an annual growth of 2.6%. The market growth is attributed to the expansion of data center infrastructure, which necessitates a reliable, high-capacity power demand year-round, supporting market growth.
