Summary

- The Brazilian fragrances market recorded revenues of \$6,490.1 million in 2024, representing a negative compound annual growth rate (CAGR) of 3.5% between 2019-24.
- Market consumption volumes declined with a negative CAGR of 0.7% between 2019-24, reaching a total of 199.8 million units in 2024.
- The contracted growth of the Brazilian fragrances market during 2019-24 can be attributed to the prolonged economic volatility, including inflationary pressures and weak consumer confidence, which likely suppressed discretionary spending on nonessential items like perfumes.
