- The global baby personal care market recorded revenues of \$50,080.8 million in 2024, representing a compound annual growth rate (CAGR) of 2.4% between 2019-24.
- Market consumption volume increased with a CAGR of 2.8% between 2019-24, reaching a total of 7,481.7 million units in 2024.
- The growth of the global baby personal care market during 2019-24 was driven by the increase in birth rates. According to the US Census Bureau, in 2024, the total number of births in the UK reached 738.9 thousand, a 3.7% increase from 2019. This rise in the newborn population effectively increased the addressable consumer base for essential categories such as diapers, wipes, and skincare products.
