Take-home and bulk ice cream segment covers larger packaging formats such as tubs, pints, and multi-pack products.
- The Singaporean ice cream market recorded revenues of \$154.4 million in 2024, representing a compound annual growth rate (CAGR) of 4.9% between 2019-24.
- Market consumption volume increased with a CAGR of 1.3% between 2019-24, reaching a total of 8.9 million kilograms in 2024.
- The Singaporean ice cream market demonstrated growth during the review period, driven by the country's strong economic growth and high consumer purchasing power.
