- In 2024, the revenue of the German rail freight sector grew by 2.4% annually, fueled by rapid economic development and industrial activities, particularly mining and the development of real estate. For instance, according to GlobalData, the German real estate industry grew 3.1% in 2024, from 2.1% in 2023.
