- The Brazilian sports equipment retail market recorded revenues of \$3,169.0 million in 2024, representing a compound annual growth rate (CAGR) of 0.4% between 2019 and 2024.
- Other specialist retail accounts for the largest proportion of sales in the Brazilian sports equipment retail market in 2024. Sales through this channel generated \$1,067.4 million, equivalent to 33.7% of the market's overall value.
- In 2024, the Brazilian sports equipment retail market contracted by 3.2% annually, primarily due to economic uncertainty, persistent inflation, and limited disposable income, has discouraged Brazilians from purchasing discretionary goods like sports gear and apparel.
