- The Swiss syrups and spreads market experienced healthy growth during the review period (2019-24), driven by several structural and lifestyle shifts in Switzerland. These shifts include rising urbanization, greater health awareness, expanding e-commerce, and the recovery of tourism consumer investment in gourmet foods, particularly those featuring jams and preserves, which has strengthened.
