- The Canadian cat care market recorded revenues of \$1,909.3 million in 2024, representing a compound annual growth rate (CAGR) of 3.2% between 2019-24.
- The cat food segment accounted for the market's largest proportion in 2024, with total revenues of \$1,566.7 million, equivalent to 82.1% of the market's overall value.
- The Canadian cat care market experienced moderate growth during 2019-24, driven by steady demand for essential products such as food and litter, alongside a shift toward premium and health-focused offerings.
