- The cat food segment accounted for the market's largest proportion in 2024, with total revenues of \$19,980.2 million, equivalent to 80.7% of the market's overall value.
- The European cat care market experienced moderate growth from 2019-24, primarily due to rising cat ownership and a shift in consumer attitudes towards viewing cats as family members.
