- The German cat care market recorded revenues of \$3,194.7 million in 2024, representing a compound annual growth rate (CAGR) of 6.9% between 2019-24.
- The cat food segment accounted for the market's largest proportion in 2024, with total revenues of \$2,302.1 million, equivalent to 72.1% of the market's overall value.
- The German cat care market grew at a healthy rate during 2019-24 due to rising cat ownership, premiumization of products, and changing consumer behaviour.
