The cat treats & milk segment includes soft treats, crunchy treats, dehydrated fish or meat treats, dental treats, etc. The cat milk segment covers powdered cat milk formulas, flavored cat milk drinks, etc. The market is valued according to retail selling price (RSP) and includes any applicable taxes.
- The Indonesian cat care market recorded revenues of \$330.2 million in 2024, representing a compound annual growth rate (CAGR) of 2.3% between 2019-24.
- The cat food segment accounted for the market's largest proportion in 2024, with total revenues of \$287.6 million, equivalent to 87.1% of the market's overall value.
- The Indonesian cat care market grew at a moderate rate during 2019-24 and is expected to continue similarly through 2024-29 due to several key factors, such as rising cat ownership, especially in urban areas with smaller households, which has steadily increased demand for cat food, grooming products, and health supplements.
