The cat treats & milk segment includes softy treats, crunchy treats, dehydrated fish or meat treats, dental treats, etc. The cat milk segment covers powdered cat milk formulas, flavored cat milk drinks, etc. The market is valued according to retail selling price (RSP) and includes any applicable taxes.
- The Singaporean cat care market recorded revenues of \$46.3 million in 2024, representing a compound annual growth rate (CAGR) of 5.9% between 2019-24.
- The cat food segment accounted for the market's largest proportion in 2024, with total revenues of \$32.4 million, equivalent to 69.9% of the market's overall value.
- The Singaporean cat care market experienced healthy growth during 2019-24 and is expected to continue expanding through 2029. Key drivers include a rise in cat ownership, the humanization of pets, with owners increasingly treating cats as family members, boosting demand for premium food, health supplements, and accessories.
