- The Swiss cat care market recorded revenues of \$865.6 million in 2024, representing a compound annual growth rate (CAGR) of 4.5% between 2019-24.
- The cat food segment accounted for the market's largest proportion in 2024, with total revenues of \$782.4 million, equivalent to 90.4% of the market's overall value.
- The Swiss cat care market experienced healthy growth during 2019-24, driven by rising cat ownership, premiumisation, and the humanisation trend.
