- The dog food segment accounted for the market's largest proportion in 2024, with total revenues of \$6,524.2 million, equivalent to 88.5% of the market's overall value.
- The Mexican dog care market grew at a strong pace during 2019-24, primarily due to an increase in disposable income among the population. This financial flexibility allowed pet owners to spend more on their dogs' care.
